#### Rotations

#### Training and coaching

The Finance MBA LDP includes at least 40 hours of classroom and online training that can be customized to individual needs and goals. For example, one key element of the curriculum, "Management Fundamentals" in year two, combines e-learning and classroom training to develop critical organizational and peopledevelopment skills.
